



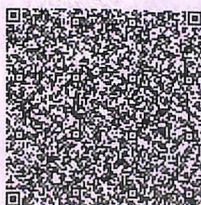

KNOW ALL MEAN BY THESE PRESENT THAT STATE BANK OF INDIA , a banking company incorporated and registered under companies Act, and carrying on its business under banking regulation Act The company having its register office at and branch office at state of india ,UNIVERSITY ROAD RAJKOT,(hereinafter called " The Surety " which expression shall unless excluded by or repugnant to the context include her heirs , administrators and assigns)bind ourselves jointly and severally to pay the Governor of Gujarat (herein after called " the Government ") on demand and without demur a sum of Rs. 5,00,000 /- (Rs. Five Lacs only) at the excluded by or repugnant to the context include her heirs, administrators and assigns) dated this 25.01.2023

WHEREAS the government has decided to prescribed a condition for admission to the government medical collage for M B.B.S. degree course (hereinafter referred to the " said course") that every student so admitted shall complete the said course from that collage or from any other collage in state and that on such completion she shall if so requires by the Government to serve in any of the rural areas (as per Govt. Notification) of the state for a minimum period of one year including one year service in any of the rural areas (as per Govt. Notification) of the state on such remuneration as may be prescribed thereof and shall furnish a suitable bond for the due performance of the said conditions.

AND WHEREAS THE STUDENT WHO HAD APPLIED FOR ADMISSION FOR THE SAID COURSE IN " THE DEAN , B. J. MEDICAL COLLAGE , AHMEDABAD . (HEREINAFTER REFERRED TO US " the said collage ') has been admitted for the said course.

NOW THECONDITION OF THE ABOVE WRITTEN OBLIGATIONS IS THAT STUDENT SHALL:

- (1) Diligently prosecute and complete tha said course at the said collage or any other medical collage in the STATE and pass the prescribed university examination for the said course , and strictly comply with rules of the said collage
- (2) Within a period of 30 days from the date of her completing the period of internship or rotating horsemanship give to the Government by registered post office in writing intimating completion of her period of internship of horsemanship provided however that if the student is desirous for continuing post graduate studies. Such notice shall expressly specify such desire and request for permission of the Government to continue such post Graduate studies and it shall be open to the Government in its absolute discretion to refuse such permission or to grant it subject to the condition that the student within one month from completion of post graduate course give a like notice to the Government
- (3) When called upon by the Government at any time within a period of six month from the receipt of the notice from the student as aforesaid join the state services and serves in any of the rural areas (as per Govt. Notification) of the state for a minimum period of one year in any of the rural areas (as per Govt. Notification) of the state at such remuneration as may be prescribed thereof and in event of the student not being so called upon by the Government to join the state services and serve them for aggregate period on one year service in any of the rural areas (as per Govt. Notification)of the state and during the period which the student is required to serve under the

provisions of this bond faithfully discharge the duties assigned to her by the Govt. or her other superior which utmost diligences and efficiency and shall observe that rural for time being enforce regulating the conduct of persons so serving.
